Application Deadline: March 1 (Applications will be accepted after March 1st on a space available basis.)

Booth Size and Assignment:

If you are offering only volunteer services, you do not need a booth, but are encouraged to bring one to advertise your cause. Available booth sizes are 10'x10'. There is no booth fee, unless you plan on selling any products or services. Let Thanksgiving Point know of any electrical needs when you send in your application so that we can do our best to accommodate your needs.

Set Up:

You may set up on the following date:

Friday, April 6th

Operational: Saturday, April 7th 10:00am-3pm

Booths must be staffed at all times and remain open until 3:00pm day of Festival.

Vendors are responsible to bring their own loading /unloading equipment. All booths should be set up and ready for the public by 9:30 AM. Gates will open at 9:30am.

Parking :

You may drive your vehicle onto the park for loading and unloading purposes only. All vehicles must be outside of the park by 9:15am, April 7th. To make parking more accessible to our guests, volunteers will be required to park in the south parking lot.

Clean Up:

Take-Down Hours: 3 PM- 4 PM

Early tear down is not permitted. Vendors are responsible for cleanup of their space as well as any materials originating from the space.

Security and Loss

Thanksgiving Point is not responsible for any injury, theft, or damage to either the buyer or seller, or their property arising out of or pertaining to preparation for or participation in Easter Eggstreme; whether such injury, theft or damage occurred prior, during, or after Easter Eggstreme. Provide Thanksgiving Point with a copy of certificate of liability insurance coverage a minimum of 10 days prior to event, listing Thanksgiving Point as an additional insured for a minimum of \$1,000,000 per occurrence. The Event Manager may require removal of any items that become a problem for the public or other booths.

Impossibility

Thanksgiving Point Institute reserves the right to terminate this contract if we think that there has been a misjudgment or misrepresentation of the type of booking. If the group's intentions are deemed to be controversial or destructive in any way Thanksgiving Point reserves the right to terminate that vendor's existence in the event.
